PUBLIC MEETING AND WORKSHOP NOTICE AND AGENDA

Pursuant to Nevada Revised Statute NRS 233B.0608

The Department of Employment, Training and Rehabilitation (DETR) will hold a public meeting and workshop on the date, time and at the locations noted below to solicit public comment on DETR's regulations contained in the Nevada Administrative Code (NAC) pursuant to **Governor Lombardo's Executive Order 2026-003** published at: <https://www.gov.nv.gov/executive-actions/executive-orders/2026-executive-orders/eo-2026-003/> , wherein:

SECTION 1: Every executive branch department, agency, board, and commission shall hold a public hearing, after having provided reasonable notice consistent with Chapter 241 of the Nevada Revised Statutes, to key industry stakeholders, to: (i) solicit from those stakeholders recommendations regarding regulations that should be streamlined, clarified, or removed; (ii) undertake a comprehensive review of the regulations subject to its enforcement; and (iii) identify other regulatory changes the subject department, agency, board, or commission determines worthy of consideration. Any meeting(s) necessary to carry out the directives in this Section must be held no later than October 29, 2026.

SECTION 2: After receiving the comprehensive stakeholder input described in Section 1, every executive branch department, agency, board, and commission shall substantively review the regulations discussed and/or proposed for revision or removal during those meetings. On or before December 31, 2026, each department, agency, board, and commission shall provide a report to the Governor's office detailing how the regulations subject to its enforcement can be streamlined, clarified, reduced, or otherwise improved to ensure those regulations provide for the general welfare of the State without unnecessarily inhibiting economic growth.

SECTION 3: As part of its report, every executive branch department, agency, board, and commission shall provide a list of between five (5) and ten (10) regulations recommended for such consideration, ranking them in descending order of priority. Additionally, each report shall include a description of: (i) any recommendations raised by stakeholders; (ii) whether those recommendations were accepted and incorporated into the department's, agency's, board's, or commission's final recommendation; and (iii) if those recommendations were not incorporated, an explanation for that non-incorporation.

SECTION 4: Reports shall be emailed to the Governor's Office at regreview@gov.nv.gov no later than December 31, 2026. Any questions from any executive branch department, agency, board, or commission regarding reporting obligations should be sent to the same address.

The purpose of this public meeting workshop is to receive comments from all interested people regarding DETR's regulations in compliance with **Executive Order 2026-003**, as outlined above.
