**NOTICE OF PUBLIC HEARING PER EXECUTIVE ORDER 2026-003
PROVIDING FOR THE REVIEW OF REGULATIONS OF
THE FINANCIAL INSTITUTIONS DIVISION
AND HEARING AGENDA**

The State of Nevada, Department of Business and Industry, Financial Institutions Division ("Division"), hereby provides notice of a public hearing concerning Governor Lombardo's Executive Order 2026-003. The purpose of the hearing is to solicit comments and recommendations from interested persons and stakeholders regarding the Division's existing regulations contained in NAC Chapters 604A, 604C, 604D, 628B, 645G, 649, 670B, 671, 675, and 676A, and whether those regulations may be appropriate for streamlining, clarification, revision, or removal.

The regulations above address non-depository financial institutions: deferred deposit loans, high-interest loans, title loans, check cashing, consumer litigation funding, earned wage access, private professional guardians, exchange facilitators, collection agencies and debt buyers, student loan servicers, money transmitters, installment loans, and debt-management/settlement services.
