The Nevada State Board of Medical Examiners (Board) will hold a public hearing at 10:30 a.m., on Thursday, October 22, 2026, at the Board's Reno office located at 9600 Gateway Drive, Reno, Nevada 89521, the Board's Las Vegas office located at 325 E. The purpose of the hearing is to review the regulations contained in NAC Chapter 630 and to comply with Nevada Governor Lombardo's [Executive Order 2026-003](#), specifically to (1) solicit recommendations from stakeholders regarding regulations contained in NAC Chapter 630 that should be streamlined, clarified, or removed; (2) undertake a comprehensive review of the regulations contained in NAC Chapter 630, and (3) identify other regulatory changes that the Board determines are worthy of consideration.

The Board's regulations are contained in [NAC Chapter 630](#). Regulations contained in LCB File No. R117-24 have been adopted by the Board, approved by the Legislative Commission, and are effective as of August 20, 2026. They are not yet codified and are available on the State of Nevada's Register of Administrative Regulations, by clicking this link: [LCB File No. R117-24](#).

Persons wishing to comment upon the Board's regulations may appear at the scheduled public hearing or may address their comments, data, views, or arguments, in written form, to the Nevada State Board of Medical Examiners, 9600 Gateway Drive, Reno, Nevada 89521. To be addressed at the public hearing, written submissions must be received by the Nevada State Board of Medical Examiners on or before 10:30 a.m. on Thursday, October 22, 2026. However, the Board will accept written comments regarding its regulations for inclusion in the report to be submitted to the Governor pursuant to Executive Order 2026-003 if those comments are received by 5 p.m. on Thursday, October 29, 2026. If no person who is directly affected by the proposed action appears at the hearing at 10:30 a.m. on October 22, 2026 to request time to make an oral presentation, the Nevada State Board of Medical Examiners may proceed immediately to act upon any written submissions.
