3. Discussion concerning amendments/repeal of regulations including NAC 706.471 and within NAC Chapter 706.450 et seq. Review of the changes made by the Legislative Counsel to the temporary 2025 NAC 706 amendment/deletions previously approved by the Board and a discussion/revision/addition of language re rides using technology applications that may affect rates including Transportation Network Company (“**TNC**”) apps and third-party technology service providers’ platforms to deploy electronic ride hailing (“**ERH System**”) programs for taxicab dispatch to fleets and currently in pilot status with the Board.
