NOTICE OF HEARING FOR THE ADOPTION, AMENDMENT OR REPEAL OF REGULATIONS OF THE COMMISSION OF APPRAISERS OF REAL ESTATE

LCB FILE No. R018-25

The Nevada Commission of Appraisers of Real Estate will conduct a public hearing at **9:00 a.m. on Tuesday, April 21, 2026**. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulations that pertain to Chapter 645C of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.060:

Information Regarding Adoption

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either prior to adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption, and incorporate therein its reason for overruling the consideration urged against its adoption.

1. Purpose and need of the proposed regulations

The experience requirements for certification and licensing are being adjusted to align with national standards. The experience hours and commission meeting attendance requirements for interns are being adjusted in an effort to decrease the licensing process. The names for required USPAP courses are being updated to the approved names by The Appraisal Foundation.

2. Terms of the proposed regulations

- Update to the name of the National USPAP Continuing Education Course
- Update to the name of the National USPAP Course
- Standards for insufficient fund transactions
- Requirements for intern experience hours
- Requirements for residential appraiser experience
- Requirements for certified residential experience
- Requirements for certified general experience
- Standards for licensing reciprocity
- Standards for supervisory appraiser status
- Education requirements for renewal of certificate and/or license
- Amended instructor qualifications
- Additional required instruction courses

3. Estimated Economic Effect

(a) Adverse effects:

The amended requirement for interns to attend commission meetings prior to licensing, should reduce the timeframe of the licensing process for new applicants. Aligning the experience requirements to the national standards will not have any adverse impact on business. The reduction of the timeframe for supervision, may benefit the interns as well, allowing them to complete their training and work in a more expeditious manner.

(b) Beneficial effects:

The additional changes to the attendance for commission meetings, and the lessening of restrictions on interns should help increase the number of appraisers throughout the state. The public will benefit as there will be a larger selection of professionals to choose to hire. The industry will benefit as there will be continued growth in the number of licensed professionals.

(c) Immediate effect:

An increase in the number of interns for an approved supervisor will allow more interns to gain appraisal experience and allow Supervising Appraisers to mentor future appraisers. Thereby increasing the number of appraisal services available for the public and private industry throughout the state. The reduction of experience hours required will increase the number of appraisers throughout the state, especially in the

(d) Long term effects:

The increased number of appraisers throughout the state, especially in the rural areas of the state, will provide more diverse options of appraisal professionals and increase business for the appraisal industry.

4. Estimated Cost to the Agency.

There will be no additional cost to the agency for enforcement of LCB File No. R018-25.
